In 1955 the firm merged with Renaud, Fellows-Smith and Mooney with whom they had a long and close association. This resulted in a name change to Mooney Ford and Partners. The firm continued under this name from 1955 to 2002 when it changed its name to the present-day Mooney Ford Attorneys. Various prominent lawyers have practiced at Mooney Ford, including the legendary Jack Mooney, a well-known sportsman, and Wally Chaplin, who, in the 1960's, was President of the Natal Law Society, as it was then known, and President of the then Association of Law Societies. Today, Mooney Ford is made up of a number of partners practicing in various specialist and general fields of law. The firm's head office is located at The Boulevard in Park Lane, Umhlanga Ridge, Durban and also offers a conveniently located branch office at Bristol House in Hillcrest for those clients who live and work in the outer west area of eThekweni.



General Litigation

Refers to litigation and all other aspects of law which may or may not be litigious in nature such as wills/estate planning, incorporating businesses, contract drafting, real-estate transactions, disputes with administrative bodies, and more.

Corporate Law

Also referred to as Company Law, it is mainly defined as the law of how businesses or corporations, shareholders, employees, directors, creditors, consumers, environment and the community interact with each other.

Commercial Law

Commercial law, also known as trade law, is the body of law that applies to the rights, relations, and conduct of persons and businesses engaged in commerce, merchandising, trade, and sales.

Insurance Law

This is the laws and regulations that relate to insurance. Insurance is a contract between two parties that transfers the risk of loss to the other party to the contract in exchange for a fee or premium.

Conveyancing

The legal process whereby a person, company, close corporation or trust becomes the registered and legal owner of immovable property, including improved and unimproved land, houses, farms, flats and sectional titles.

Debt Collection

Debt collection is the process of pursuing payments of debts owed by individuals or businesses.

Public Law

Public law is that part of law which governs relationships between individuals and the government, and comprises constitutional law, administrative law, tax law and criminal law, as well as all procedural law.

Competition Law

Law that promotes or seeks to maintain market competition by regulating anti-competitive conduct by companies. Competition law is implemented through public and private enforcement.

Insolvency Law

The law of insolvency envisages and accounts for sequestration of individuals and liquidations of companies, amongst various other mechanisms and processes which the law of insolvency provides for including business rescue.

Deceased Estates

The law of succession is the totality of the legal rules which control the transfer of those assets of the deceased which are subject to distribution among beneficiaries, or those assets of another over which the deceased had the power of disposal.

Alternate Dispute Resolution

ADR is a mechanism used by parties who want to avoid having to go to court to resolve a dispute that they have.

Labour Law

South African labour law regulates: the rights/obligations between employers, employees, and trade unions; including dispute resolution mechanisms applicable to dismissals for misconduct, incapacity and operational requirements, collective bargaining; and OHSA.
